ITEM 1. ROLL CALL/CALL TO ORDER

The Citizens Multimodal Advisory Committee (CMAC) meeting was conducted as a Zoom Webinar. The meeting was called to order at 5:30 p.m. by the Chair, Lindsey Costello.

ITEM 5. RECOMMEND APPROVAL OF THE PROPOSED AMENDMENT NO. 3 TO THE FFY 2021-2025 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP)

Graham Dollarhide, RTC Senior Technical Planner gave a presentation on the proposed Amendment No. 3 to the FFY 2021-2025 RTIP.

Mathew Boog asked if there was funding from Nevada Department of Transportation (NDOT) for the Villanova maintenance facility replacement. Graham Dollarhide, RTC Senior Technical Planner stated NDOT is funding part of the relocation. Jim Gee, RTC Service Planning/Innovation Manager stated the project is a multi-year with different funding sources and an agreement with NDOT for the facilities transit improvements is for part of the funding.

Sue-Ting Chene entered the meeting at 5:39 p.m.

Greg Newman asked about the Keystone Bridge Project and delay impacts. Dan Doenges, RTC Director of Planning stated NDOT is responsible for inventory on all the bridges from the state. He stated it is on the NDOT list for priority.

Greg Newman made a motion to recommend approval of the proposed Amendment No. 3 to the FFY 2021-2025 Regional Transportation Improvement Program (RTIP).

Jeff Bonano seconded.

The motion carried unanimously.

ITEM 6. ACKNOWLEDGE RECEIPT OF AN UPDATE REGARDING THE ARLINGTON AVENUE BRIDGES REPLACEMENT PROJECT

Judy Tortelli, RTC Engineering Project Manager gave a presentation on the update regarding the Arlington Avenue Bridges Replacement Project. A copy of the PowerPoint presentation is on file at the RTC Metropolitan Planning Department.

Ben Miller asked about a discussion on putting a pedestrian underpass on the north bank of the north bridge at the bike path. Judy Tortelli, RTC Engineering Project Manager stated, RTC did not look at providing a bike path on the north side being the south side will be rebuilt. Ben Miller gave a suggestion on adding the steal bollards like on Victorian Avenue to shut down for Art town concerts. Judy Tortelli, RTC Engineering Project Manager stated, the City of Reno has requested for removable bollards for events.

Ann Silver recommended for RTC to serve on the Reno Sparks Convention Visitors Authority (RSCVA) board for events for knowledge on tourists, visitors and cultural events. There was a

discussion on the detours and speed limit during closing for construction on the Arlington Bridges Replacement Project. Dennis Colling had concerns on the time of the closing for the construction. Judy Tortelli, RTC Engineering Project Manager stated, July through November timeframe for construction is due to non-flood season and of the aquatic impacts. There was a discussion on the surveys from the public meetings and bike detour routes. Mathew Boog asked if anything is being done about the speed limits on the road at Arlington Avenue. Judy Tortelli, RTC Engineering Project Manager stated, that the striping of the road lane, buffered bike lanes, and a speed study for determination of slowing traffic is being conducted.

Greg Newman asked of the changes on the north bridge from the two columns to one column. Judy Tortelli, RTC Engineering Project Manager stated, the reason is the deck thickness is with limited room to make it comfortable to pedestrians. There was a continued discussion on the detours of the project. There was a discussion on the closing of the Arlington Avenue Bridges Replacement Project for construction.

Ann Silver made a motion to acknowledge receipt of an update regarding the Arlington Avenue Bridges Replacement Project.

Paul Hewen seconded.

The motion carried unanimously.

BACKGROUND AND DISCUSSION

The Nevada Department of Transportation (NDOT) developed the Nevada State Freight Plan (Plan) which describes the framework needed to create the robust and reliable freight transportation infrastructure necessary for Nevada's continued economic growth and diversification. The Plan identifies freight transportation hubs and facilities critical to Nevada's economic growth and recommends appropriate prioritization for investments in these hubs and facilities.

NDOT is currently working on updating the Plan. This presentation provides an overview of the Plan and a freight data analysis for potential updates on identifying roadways to be included in the Critical Urban Freight Corridor designation in Washoe County.

RECOMMENDED ACTION

Acknowledge receipt of presentation on Vision Zero Truckee Meadows Action Plan, 2022 Update.

BACKGROUND AND DISCUSSION

The Vision Zero Truckee Meadows Task Force recently completed an update to the Vision Zero Truckee Meadows Action Plan. Vision Zero Truckee Meadows is a regionwide effort to eliminate all traffic-related serious injuries and deaths by the year 2030. The original Action Plan was adopted in 2019 and was revised to incorporate new safety data and position the region for new federal funding sources.

This update was led by the Regional Transportation Commission (RTC) and incorporated comments from other Vision Zero Truckee Meadows Task Force agencies. Applying new safety data and analyses, the update resulted in additional Action Items that were used as high priority projects in a Safe Streets and Roads for All grant application that was submitted in September 2022. If funded, projects would improve safety through evidence-based solutions along multiple corridors throughout Reno, Sparks, and unincorporated areas of Washoe County. These and other updates and projects will be covered in the associated presentation.
