#### ITEM 1. **APPROVAL OF AGENDA**

## ITEM 4. ACKNOWLEDGE RECEIPT OF REPORT ON THE CENTER STREET MULTI-MODAL IMPROVEMENTS PROJECTS

Maria Paz Fernandez, RTC Project Manager gave a presentation for the Center Street Multi-Modal Improvement Project which, the project limits at Midtown to UNR, goals, proposed design concepts and proposed lanes were presented. The PowerPoint presentation is on file at the RTC Metropolitan Planning Department. She stated the project timeline will be at 30% design in spring of 2021 and construction for the project in the summer of 2023.

#### ITEM 5. RECOMMEND APPROVAL OF THE PROPOSED AMENDMENT NO. 3 TO THE FFY 2020-2024 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP)

Dan Doenges, RTC Planning Manager briefed the committee on the proposed Amendment NO. 3 to the FFY 2020-2024 Regional Transportation Improvement Program (RTIP). A correction to the RTIP's title was made. He stated the proposing Amendment NO.3 to the RTIP had scope of work changes to the projects and the re allocating of federal funds and NDOT projects are also included as well. He stated no air quality analysis for the proposed amendment was required as there are no capacity projects. The Public Comment Period began on October 30, 2020, and will close on November 19, 2020. A Public Hearing will be held at the RTC Board meeting on November 20, 2020, for approval from the RTC Board.

Vice-Chair, Julee Olander, made a motion to recommend approval of the proposed Amendment NO. 3 to the FFY 2020-2024 Regional Transportation Improvement Program (RTIP).

Jillian Emery, NDOT seconded.

#### ITEM 6. ACKNOWLEDGE RECEIPT OF A REPORT ON THE 2050 REGIONAL TRANSPORTATION PLAN (RTP) TRANSPORTATION PRELIMINARY EVALUATION OF PROJECTS

Amy Cummings, RTC Director of Planning briefed the committee of the Report on the 2050 Regional Transportation Plan (RTP) Transportation Preliminary Evaluation of Projects. She gave a presentation on one project study, The Downtown Circulation Project which, is considered in the projects for the 2050 RTP. A copy of the PowerPoint Presentation is on file at the RTC Metropolitan Planning Department. She stated a virtual public meeting of the corridor study will be next and input from the meeting will be incorporated in the 2050 RTP for future studies on the corridor.

Chris Tolley, TMRPA made a motion to acknowledge receipt of a report on the 2050 Regional Transportation Plan (RTP) Transportation Preliminary Evaluation of Projects.

Kurt Dietrich, City of Reno gave member items on traffic signal improvement projects and the received RFB project with the TA-Set Aside program. He stated there is in house coordination on that project.

Tara Smaltz, NDOT gave a member item on the Spaghetti Bowl Express (SPX) project. She stated the re-opening of the southbound lanes for alleviation of traffic and also in November the northbound area will do the same. She stated the North McCarran Project is ongoing at this time.

Rebecca Kapuler, RTC Senior Technical Planner announced the #Dusk2DawnNV Campaign which, is in conjunction with Las Vegas. She stated posters were distributed by the Vision Zero Truckee Meadows Task Force (VZTM TF) at Midtown and Downtown Sparks and 2,400 wrist slappers were handed out at various locations. She emphasized the time change and the 80% fatalities which, occur when dark. She provided the Vision Zero video link for sharing with others which, is at RTC's social media or <u>www.visionzerotruckeemeadows.com</u>.

#### SUBJECT: 2050 Regional Transportation Plan Project Evaluation

#### **RECOMMENDATION**

Acknowledge receipt of a report on the 2050 Regional Transportation Plan (RTP) and provide input.

#### **SUMMARY**

The RTC recently issued a call for projects in an effort to seek agency and public input about projects to consider in the 2050 RTP. An online survey was also provided as part of this effort. Staff is currently evaluating projects that were suggested for potential inclusion in the plan, and a follow up survey will be provided to gather feedback on public priorities.

Concurrently, staff conducted the Downtown Reno Circulation Study, which aims to contribute to Downtown as a safe and attractive destination, support a revitalized Downtown with vibrant public spaces, encourage safe multimodal access to jobs, entertainment, and special events, and connect Downtown to surrounding neighborhoods and the University. The RTC is inviting the community to participate virtually by watching a video presentation of the Downtown Reno Circulation Study and providing comments. The RTC is accepting comments through Friday, December 11, 2020.

In addition, staff recently presented a draft transit vision to the RTP Agency Working Group and RTC Board, as part of the 2050 RTP. The transit vision includes the following elements:

#### **Transit system priorities:**

- Provide a productive, cost effective, high quality transit service with a positive customer experience
- Focus on providing workforce mobility & attracting new riders
- Use innovative approaches to maximize mobility with the limited resources available

## Vision for Future Service (unfunded at this time):

- Increase frequency or span of service strategically on existing high-performing routes to increase ridership

- Use FlexRIDE to replace lower-performing fixed routes and provide service to outlying areas, as appropriate
- Extend RAPID service:
  - Lincoln Line on West 4<sup>th</sup> Street
  - Virginia Line on South Virginia
  - Work with regional partners to bring housing and employment density to RAPID corridors

#### Maintenance Facility Needs (unfunded at this time):

- Relocation of Villanova facility due to Spaghetti Bowl Project (this phase of Spaghetti Bowl is in 2037-2040)
- Expand Sutro maintenance facility
- Expand zero emission fueling capabilities

#### **Passenger Facility Needs:**

- Peppermill Station upgrade (funded)
- Expand 4<sup>TH</sup> STREET STATION (funded)
- Bus stop accessibility improvements (funded)
- West 4<sup>th</sup> Street & Sparks mobility hubs
- Meadowood Mall transfer station relocation
