ITEM 1. CALL TO ORDER/ROLL CALL

The Technical Advisory Committee meeting was conducted as a Zoom Webinar. The meeting was called to order at 9:03 a.m. by the Chair, Kurt Dietrich.

ITEM 2. APPROVAL OF AGENDA

The agenda was approved as submitted.

ITEM 3. VERBAL INSTRUCTIONS REQUIRED BY ASSEMBLY BILL 219 (2023)

ITEM 5. APPROVAL OF THE OCTOBER 5, 2023 AND NOVEMBER 2, 2023, MEETING MINUTES

The TAC October 5, 2023 and November 2, 2023 meeting minutes were approved as submitted.

ITEM 6. RECOMMEND APPROVAL OF THE PROPOSED AMENDMENT NO. 2 TO THE REGIONAL TRANSPORTATION PLAN (RTP) AND AMENDMENT NO. 2 TO THE FFY 2023-2027 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP)

Graham Dollarhide, RTC Senior Technical Planner gave a presentation on the proposed Amendment No.2 to the RTP and Amendment No. 2 to the RTIP. A copy of the Power presentation is on file at the RTC Metropolitan Planning Department.

Scott Carey asked of the Pyramid and Highland Ranch, Pyramid HWY project timeline. Graham Dollarhide, RTC Senior Technical Planner and Dale Keller, RTC Director of Engineering stated the LPA agreement with NDOT of committed funds were updated from FY23 to FY24. RTC has Parametrix as the consultant for the next phase on the project. Scott Carey asked about the 6th Street mobility project increase in funding. Graham Dollarhide, RTC Senior Technical Planner stated the budget has changed in terms of design and element impacts and SS4A award funds. Scott Carey asked about Geiger Grade/Toll Road project time line. Graham Dollarhide, RTC Senior Technical Planner stated the timeline for that project is 2026 to 2027 and Dale Keller, RTC Director of Engineering stated due to the natural resources for the environmental process the projects timeline is FFY 2027.

Amber Sosa made a motion to recommend approval of the proposed Amendment No. 2 to the Regional Transportation Plan (RTP) and Amendment No. 2 to the FFY 2023-2027 Regional Transportation Improvement Program (RTIP).

Craig Petersen seconded.

The motion carried unanimously.

ITEM 7. DEVELOPMENT UPDATES

Scott Carey, City of Sparks gave updates on a new development at Stonebrook in Spanish Springs and announced the City of Sparks council meeting is on Monday, January 8, 2024, and will be looking at a final map for Village 11 in the Pioneer Meadows development. He stated that he attended the VRU assessment workshop.

ITEM 8. MEMBER ITEMS

Amber Sosa gave updates for the new projects that are upcoming and the new fire station will be opening in a few days.

Craig Petersen, Northern Nevada Public Health Air-Quality Management Division announced a second draft of the second 10 year PM₁₀ Maintenance Plan which, was sent to EPA on December 28, 2023 will be reviewed for received comments at the end of January. The draft will then reopen for a 30-day public comment period with the board adoption at the end of March 2024, which will set the motor vehicle emissions budget.

Damien Kerwin, TMRPA announced a Public Infrastructure Plan community conversation that TMRPA is hosting on January 17, 2024, at 6:00 p.m. at the Discovery Museum. TMRPA is reviewing the Washoe County Master Plan for a conformance to the Regional Plan and a public meeting will be held for the Planning Commission on January 25, 2024.

Kyle Chisholm, WCSD announced the Washoe County School Board approved their Facilities Modernization Plan for all the schools in Washoe County on December 12, 2024, The Facilities Modernization Plan or the board meeting is available on their website for review of the documents.

Candace Stowell, RSIC announced the Transportation Safety Plan is underway. The RSIC Senior Planner, Brian Newman is coordinating with RTC, stakeholders and NDOT. In January, there will be new updates on the Truckee Meadows Public Lands Management Act.

RECOMMENDED ACTION

Provide feedback and acknowledge receipt of a report on Fiscal Year 2025 Transit Optimization Plans Strategies (TOPS) recommended service changes.

BACKGROUND AND DISCUSSION

In July 2022, the RTC Board approved and adopted the TOPS plan and the recommended service changes. RTC will be implement the next set of recommended service changes as indicated for the 2024 - 2025 time-period. The recommended service changes are:

- ➤ Line-of Route Change for Route 13
- Extend 10-minute headways on Virginia line to 10pm on Weekdays
- ➤ Increase Sunday mid-day service to 30-minute headways on Route 21
- ➤ Updated Levels of Service for 2024/2025 holidays
- Create Damonte/South RenoFlexRIDE zone

The following outlines the specifics of the above noted changes:

May 4, 2024 Service Change – Adjustments to Routes 13, 21, Virginia Line, & FlexRIDE

RTC is receiving public comments on the following recommended service changes:

Route modifications:

Route 13:

- Adjusts the outbound Line-of-Route by taking a right hand turn from Grove Street onto Kietzke Lane then taking a left turn on Linden Street and another left turn onto Harvard Way.
 - o Increases safety for drivers and riders by utilizing roads better able to accommodate bus-turning visibility.

Route 21:

➤ Increase the Sunday service level to 30-minute headways from the current 60-minute headways during the mid-day hours.

- o Improves frequency to the shopping, employment, and medical centers along the route according to ridership demands.
- o This will change the schedule times for this route.

Virginia Line:

- Extend the service level to 10-minute headways from 7pm to 10 pm.
 - o Improves frequency to meet ridership demands
 - o This will change the schedule times for this route.

FlexRIDE Adjustments

In an effort to continue improving public transit service to the southwest portion of the City of Reno, RTC will be expanding the FlexRIDE service by creating a new zone to include the South Meadows area. This zone will provide transit service east of the current Route 56 and will include points of interest such as the South Valleys Regional Sports Complex, UNR Redfield Campus, Damonte Ranch Town Center, Northern Nevada Medical Center and Walmart South Meadows. Furthermore, Meadowood Mall will be a connection point between the Damonte/South Reno FlexRIDE zone and the RTC Ride service.

Adjustments to Holiday Levels of Service

Staff has reviewed ridership during previous holidays and made adjustments to the levels of service to better reflect ridership on those days.

Meadowood Mall Bus Bay Assignment

As part of RTC's on-going effort to provide an easy to navigate service, staff will be creating dedicated bus bays for all routes utilizing the station. Signage to assist passengers at the Meadowood Mall transfer station will be created so that riders are better able to navigate to their bus accurately.
