RTC Transit Fixed Route Bus Highlights

October 2024

RTC Transit Fixed Route Bus

- For the month of October, there were 516,977 rides, **up 11.1%** compared with last year (page 1). Weighted average daily ridership was 16,494, **up 7.4%** compared with last year (page 3).
- For the most recent 12 months, there were 5.49 million rides **up 10.5%** compared with the previous 12 months.
- In October, there were 22,783 service hours, **up 6.1%** compared with last year (page 9).
- Productivity was 22.7 rides per service hour, **up 4.7%** compared with last year (page 9).

External Impacts on Ridership

- The average temperature this month was 58.1° F, 1.7° F higher compared with last year.
- The Reno-Sparks area preliminary unemployment rate in September was 4.7%. Unemployment has been gradually trending upward since a low of 2.8% in December 2021.
- Nevada's preliminary unemployment rate for September was 5.6%. The national unemployment rate for September was 4.1%.

Historical Impacts Causing a Downward Trend in Bus Ridership

- According to Bureau of Labor Statistics, 27% of US employees worked remotely at least part of the time in 2023, with several academic surveys suggesting it is closer to 50%*.
- In April 2022, the City of Reno entered an agreement with Bird electric scooters to serve Reno.
- In 2021, Keolis transit workers went on strike August 3 to 13, September 27 to October 20, and November 9 to December 3. Limited service was provided on Routes 1, 7, and 11 and RTC REGIONAL CONNECTOR to Carson City. RTC provided free rides on RIDE, FlexRIDE, taxis, and UberX during the second and third strikes.
- A combination of the pandemic, stimulus checks, easy car financing, and gig jobs requiring cars has likely resulted in a large number of people abandoning transit for car ownership.
- In response to the COVID-19 pandemic, Governor Sisolak ordered the shutdown of casinos and other nonessential businesses in March 2020. In May 2020, Governor Sisolak reopened a number of businesses including bars, salons, gyms, and retail. Casinos were allowed to reopen in June 2020. In May 2021, maximum business capacity increased to 100% in Washoe County.
- There has been an increase in people working primarily from home, approximately eight million in 2018 according to US Census Bureau estimates, taking over transit as the second most common means of getting to work.
- While employment has increased in the region, the makeup of local employment has significantly changed. When Reno was a tourism and gaming town, a large portion of employment was in the low-wage, service industry whereas recently jobs tend to be higher wage and geographically dispersed requiring cars.
- Uber started permanent service in Reno in 2015 and Lyft started shortly after.
- As of 2014, Nevada provides driver's licenses for people who are undocumented immigrants.
- As downtown and midtown areas in-fill and gentrify, this also pushes lower income people to the suburbs where they are much more likely to need cars. This is a nationwide trend.
- The drop in ridership (before COVID) has been a nationwide trend as illustrated by the chart on page 4 which compares RTC transit ridership with US and Canadian bus ridership.
- With the growth of online shopping and food delivery, it is also likely that bus trips used for shopping and dining out has fallen substantially, especially for those with mobility challenges who would prefer online shopping and food delivery. Also, people without cars may decide to purchase a car with the intention of using the car to deliver food and finance the car.

RTC Transit Fixed Route Bus Summary

Route Ridership

- For October, Route 1 (serving S Virginia St between downtown Reno and Meadowood Mall) had the highest productivity with 27.8 rides per service hour.
- Route 18 (serving Glendale) came in second with 27.6.
- Route 5 (serving Sutro Sun Valley) had the third highest productivity in the system with 26.4 rides per service hour (page 7).
- Route 16 (serving Idlewild) had the highest increase in ridership at 45.6%.
- Route 11 ridership had the second highest increase compared with last year by 37.7%. In May 2023, Routes 3 and 26 were eliminated with Route 11 absorbing parts of Routes 3 and 26.
- Route 21 (Sparks Marina) had the third highest increase in ridership at 22.1%.

RTC RAPID (Virginia & Lincoln Lines Combined)

- This month, there were 129,927 rides on RTC RAPID up 2.0% compared with last year. By comparison, system ridership was up 11.1%. The productivity of RTC RAPID at 27.0 rides per service hour was down 8.5% compared with last year. By comparison, system productivity was 22.7 rides per service hour, up 4.7% compared with last year.
- There were 1.411 million rides over the most recent 12 months, **up 6.0%** compared with the previous 12 months.
- RAPID rides now make up 25.1% of system ridership.
- 44.7% of all system rides were taken on RAPID and Routes 1 and 11.

RTC RAPID Virginia Line

- This month, there were 90,108 rides on the Virginia Line **up 2.8%** compared with last year. Productivity at 27.7 rides per service hour is **down 9.0%** compared with last year.
- Ridership for both the Virginia Line and Route 1 was 126,372 up 1.3% compared with last year (page 14). There were 1.39 million rides over the most recent 12 months, up 4.1% compared with the previous 12 months.

RTC RAPID Lincoln Line

- This month, there were 39,819 rides on the Lincoln Line **up 0.3%** compared with last year. Productivity at 25.7 rides per service hour is **down 7.8%** compared with last year.
- Ridership for both the Lincoln Line and Route 11 was 104,465 up 21% compared with last year (page 16). There were 1.09 million rides for the most recent 12 months, up 28% compared with the previous 12 months.

RTC REGIONAL CONNECTOR Carson Line

• There were 1,859 rides this month, **up 0.5%** compared with last October (page 18). At 6.0 rides per service hour, productivity is down 12.9% last year. There were 20,184 rides for the most recent 12 months, **up 4.0 %** compared with the previous 12 months.

RTC TMCC and UNR Education Pass

- There were 15,763 UNR Ed-Pass rides, **up 16%** compared with last year (page 20).
- There were 13,741 TMCC Ed-Pass rides, **up 60%** compared with last year.







FISCAL YEAR COMPARISONS









Weighted Average Daily Ridership Rolling 12-Month Ridership Comparison






RTC REGIONAL CONNECTOR Carson Line Fiscal Year Comparisons


