RTC Transit Fixed Route Bus Highlights August 2025

RTC Transit Fixed Route Bus

- For the month of August, there were 524,312 rides, **up 2.7%** compared with last year (page 1). The weighted average daily ridership was 17,157, **up 4.2%** compared with last year (page 3).
- For the most recent 12 months, there were 5.85 million rides, **up 8.1%** compared with the previous 12 months.
- In August, there were 22,229 service hours, down 1.7% compared with last year (page 9).
- Productivity was 23.6 rides per service hour, up 4.5% compared with last year (page 9).
- On-time performance for August is 89.13%, slightly below the 90% target, with some impacts from summer construction projects.

External Impacts on Ridership

- The average temperature this month was 75.7°F, 1.2°F higher compared with last year.
- The Reno-Sparks area preliminary unemployment rate in July was 4.3%. Unemployment has been gradually trending upward since a low of 2.8% in March 2021.
- Nevada's preliminary unemployment rate for July was 5.4%. The national unemployment rate for July was 4.2%.

Route Ridership Comparison

- For August, Route 1 (serving S Virginia St between downtown Reno and Meadowood Mall) had the highest productivity with 29.0 rides per service hour (page 7).
- Route 11 (serving Fourth Prater) came in second with 26.6.
- Route 5 (serving Sun Valley) had the third highest productivity in the system with 26.1 rides per service hour.
- Route 14 (serving East Mill) ridership had the highest increase compared with last year by 12.8%.
- Route 11 (serving Fourth Prater) ridership had the second highest increase compared with last year by 10.9%.
- Route 56 (serving South Meadows) had the third highest increase in ridership at 10.0%.

RTC RAPID (Virginia & Lincoln Lines Combined)

- This month, there were 135,740 rides on RTC RAPID, up 11.7% compared with last year. By comparison, system ridership was up 2.7%. The productivity of RTC RAPID at 28.8 rides per service hour was up 13% compared with last year. By comparison, system productivity was 23.6 rides per service hour, up 4.5% compared with last year.
- There were 1.49 million rides over the most recent 12 months, up 5.2% compared with the previous 12 months.
- RAPID rides now make up 25.9% of system ridership.
- 46.9% of all system rides were taken on RAPID and Routes 1 and 11.

RTC RAPID Virginia Line

- This month, there were 94,101 rides on the Virginia Line, **up 16.5%** compared with last year. Productivity at 29.4 rides per service hour is **up 17.9%** compared with last year.
- Ridership for both the Virginia Line and Route 1 was 131,875, **up 11.0%** compared with last year (page 14). There were 1.43 million rides over the most recent 12 months, **up 3.4%** compared with the previous 12 months.

RTC RAPID Lincoln Line

- This month, there were 41,639 rides on the Lincoln Line up 2.2% compared with last year. Productivity at 27.4 rides per service hour is up 3.3% compared with last year.
- Ridership for both the Lincoln Line and Route 11 was 113,973, up 7.6% compared with last year (page 16). There were 1.21 million rides for the most recent 12 months, up 15% compared with the previous 12 months.

RTC REGIONAL CONNECTOR Carson Line

There were 1,789 rides this month, down 4.9% compared with last August (page 18). At 6.4 rides per service hour, productivity is the same as last year. There were 20,574 rides for the most recent 12 months, up 2.5 % compared with the previous 12 months.

RTC TMCC and UNR Education Pass

- There were 12,436 UNR Ed-Pass rides, down 6.0% compared with last year (page 20).
- There were 9,828 TMCC Ed-Pass rides, up 5.3% compared with last year (page 21).





FISCAL YEAR COMPARISONS









