#### Position Overview

Under general supervision, leads the vision, strategy, and daily operations of the Customer Service, Mobility Center, and RTC's paratransit programs, including Washoe Senior Ride and FlexRIDE. This role is responsible for reimagining how RTC delivers mobility services to passengers by identifying innovative approaches, improving customer experience, and advancing more flexible, efficient, and accessible service models. The position provides leadership to the Mobility and Customer Service Teams, ensures full compliance with the Americans with Disabilities Act (ADA), oversees contractors, and builds strong partnerships across the organization and community to shape the future of mobility in the region.

#### Key Responsibilities

Duties may include, but are not limited to:

- Serve as the strategic and operational lead for RTC's paratransit programs, guiding both daily service delivery and long-term program innovation while ensuring ADA and regulatory compliance.
- Lead, coach, and develop the Mobility and Customer Service Teams, fostering a culture of collaboration, accountability, continuous improvement, and customer-centered service.

- Identify, design, and implement new service models, partnerships, and tools that enhance mobility options and improve outcomes for seniors and individuals with disabilities.
- Oversee paratransit eligibility and travel training programs, applying sound judgement and creative problem-solving to support access, independence, and equitable service delivery.
- Monitor, analyze, and act on performance data—including safety, ridership, on-time performance, staffing, and contractor performance—to drive informed decision-making and program enhancements.
- Lead collaboration on contract development, negotiation, and administration, ensuring scopes of work encourage innovation, accountability, and high-quality service delivery.
- Build and strengthen partnerships with community organizations, human service agencies, and regional stakeholders to expand mobility solutions and better serve diverse populations.
- Serve as a senior point of contact for customer concerns, eligibility issues, and service complaints, ensuring thoughtful, timely resolution and continuous service improvement.
- Champion continuous improvement through data analysis, policy development, pilot programs, special projects, and cross-departmental collaboration.

## Minimum Qualifications

To be considered, candidates must meet one of the following:

- Six (6) years of applicable experience including two (2) years in a supervisory role.
- Bachelor's degree or higher.
- Or an equivalent combination of education and experience that demonstrates the ability to perform the essential duties.
- Spanish and English bilingual skills preferred.
- Valid driver's license at time of hire is required.
